CONDITIONS RELATING TO TRADE SPACE

1. LOCAL CRAFTER MARQUEE EXHIBITORS MUST SUBMIT COMPLETED APPLICATION FORM WITH APPROPRIATE REMITTANCE TO CATRIONA GORRIE
2. EXHIBITORS MAY NOT SUB-LET ANY PORTION OF SPACE ALLOCATED TO THEM
3. THERE IS NO ELECTRICITY SUPPLY AVAILABLE ON THE FIELD
4. NO TURF MAY BE LIFTED EXCEPT WHERE ABSOLUTELY NECESSARY, IN WHICH CASE PRIOR PERMISSION MUST BE OBTAINED FROM THE SECRETARY. ANY COSTS IN RESPECT OF REINSTATEMENT OF GROUND MUST BE BOURNE BY THE EXHIBITOR
5. EXHIBITORS MUST NOT PROMOTE THEIR PRODUCE BY CREATING EXCESSIVE NOISE OR OTHER ANNOYING BEHAVIOUR
6. MID ARGYLL AGRICULTURAL SOCIETY, ITS OFFICERS & OFFICIALS SHALL NOT BE RESPONSIBLE FOR ANY ACCIDENTS, DAMAGE, OR LOSS HOWEVER CAUSED, WHICH MAY OCCUR TO ANY EXHIBITOR OR HIS REPRESENTATIVE OR TO THEIR PROPERTY.
7. EACH EXHIBITOR SHALL BE SOLELY RESPONSIBLE FOR ANY LOSS, INJURY OR DAMAGE WHICH MAY BE DONE TO, OR OCCASIONED BY, OR ARISING FROM, ANY MACHINERY OR OTHER ARTICLE OR PROPERTY OF HIS, AND IT IS A CONDITION OF ENTRY THAT EACH EXHIBITOR SHALL INDEMNIFY AND HOLD HARMLESS MID ARGYLL AGRICULTURAL SOCIETY FROM ACTION, SUIT, EXPENSE, OR CLAIM ON ACCOUNT OF ANY SUCH DAMAGE OR INJURY.
